This MoU will be Valid for Three years from 09-01-2025 and thereafter it may be renewed on mutually agreed terms.

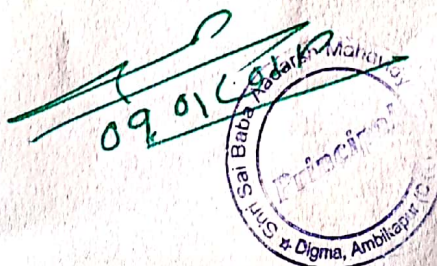
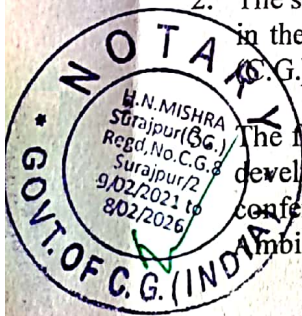
First Party

2. Intellectual Property

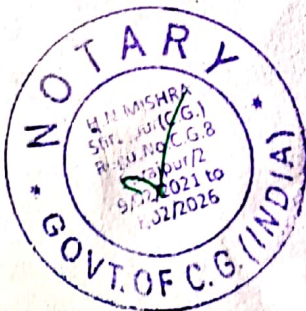
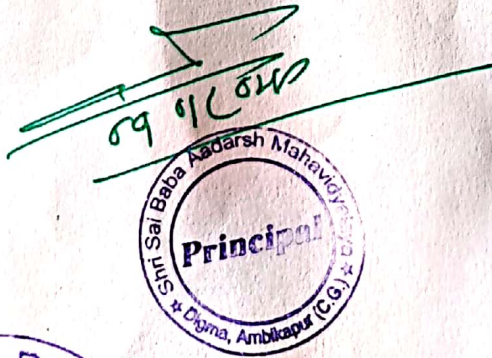
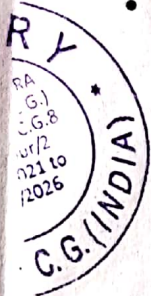
- Any research publications and intellectual property rights arising out of the students and joint research projects shall be jointly published and, when patented, will be jointly and equally owned by both parties.

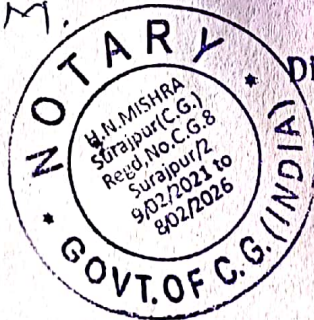
